Dear mister forgensen,

In your letter of 2 February you put forward a suggestion concerning the organization of the European Council meeting to be held in Copenhagen on 7 and 8 April. To allow more time for informal discussion, you propose that after the luncheon given by Her Majesty the Queen of Denmark on 7 April, the heads of state or government should meet separately from the foreign ministers. The heads of state or government would then hold informal talks whilst the foreign ministers would continue to prepare for the session of the European Council in its traditional form on 8 April (should this be necessary) or deal with political matters which do not need to be discussed by the Council.

Whilst recognizing the value of informal discussions between the heads of state or government of the Member States of the European Communities, I believe there is one important objection to the proposal that within the European Council meetings between the heads of state or government should be held separately from those of the foreign ministers.

It was decided at the conference of heads of state or government in Paris on 9 and 10 December 1974 that they should hold three meetings a year together with the foreign ministers. The decision to set up the European Council therefore explicitly stated that the meetings should be attended by the heads of government and the ministers

His Excellency Mr. Anker Jørgensen Prime Minister of Denmark Copenhagen for Foreign Affairs of the Member States of the Communities. This was a major condition of the Netherlands' acceptance of the institution of the European Council and the considerations which played a part in decisionmaking on the institution of the European Council at that time carry just as much weight with me.

Therefore, I would like to advocate that the arrangements regarding the organization of the European Council made by the Council on 29 and 30 June last year continue to be fully interpreted in accordance with the decision of the Paris conference in December 1974.
