

## ABOUT THE AUTHORS

*Richard Chauvel* is a graduate of the University of Sydney and the School of Oriental and African Studies in London. He has research interests in Eastern Indonesia and Australian-Indonesian relations. He took his doctoral degree with a dissertation on nationalism and separatism in Ambon during the years of decolonization. Between 1987 and 1992 he taught at the University of Indonesia. *Amapon Jos Frans Marey* was civil servant in the final days of the Dutch administration in West Papua (Netherlands New Guinea). He was adviser and interpreter of underminister (staatssecretaris) Th. Bot during his visit to New Guinea in February 1962. He also served as head of the Immigration Office during the UNTEA period in Hollandia. In September 1969 he was a member of the Papua delegation that attended the presentation of the report on the Act of Free Choice of Mr. Ortiz Sanz to the General Assembly of the UN in New York. At present he works with Initiatives of Change for peace and reconciliation between Papuans and Indonesians.

*John Saltford* was employed as a Southeast Asian specialist at the National Archives in London when he completed a Ph.D. thesis at the University of Hull in the year 2000. Two years later the book was published in a slightly revised form under the title: *The United Nations and the Indonesian Takeover of West Papua, 1962 – 1969. The anatomy of betrayal* (London-New York 2003) At present he works for the Central Government in London.

*Bilveer Singh* received his MA and Ph.D. in International Relations from the Australian National University. At present he is associate professor and Deputy Head of the Department of Political Science, National University of Singapore. He specialises on Southeast Asian security affairs with a special focus on Indonesia during and after the downfall of Suharto. At present he is preparing publications on the Anatomy of Jihadi Terrorism in Southeast Asia, and on the geopolitical implications of Papuan separatism
