

Propositions prepared by y^r Committees of both Kingdoms
for a safe & wellgrounded peace to be presented to both
houses of y^r Parliament of England & to y^r Convention of
Estates in Scotland, or their Committees to be by them
advised & considered, & then by y^r mutuall advice
& consent of both Kingdoms to be perfected.

- 1 That by act of Parliament in each Kingdom respectively all oaths
declarations, & excommunications against both houses of y^r Parliament
of England, the late Convention of y^r Estate of Scotland, or
their ordinances, and proceedings, or against any for adhering
unto them, be admitted suppressed, and voided in all y^r
mutuall Dominions.
- 2 That as act of Parliament be passed in both Kingdoms respecti-
vely, for informing y^r taking y^r late solemn League and
Covenant by all y^r subjects of y^r the said Kingdoms, and y^r Ordina-
nces concerning y^r manner of taking y^r same in both Kingdo-
ms be confirmed by acts of Parliament respectively, w^{ch} full
penalties, as by mutuall advice of both Kingdoms shall
be agreed upon.
- 3 That y^r Bill be passed for y^r better abolishing of Episcopacy w^{ch}
full alterations concerning y^r Estates of prelates as upon
consideration of y^r Treaty & former declarations of both Kingdoms
shall be found necessary.
- 4 That y^r Ordinance concerning y^r calling & sitting of y^r assemblies
of divines be confirmed by act of Parliament.
- 5 That reformation of religion according to y^r Covenant be settled
by act of Parliament in full manner as both houses shall agree
upon, after advice givⁿ from y^r Assembly of divines (and forasmuch
as both Kingdoms are mutuall^y obliged by y^r said Covenant to
Endeavour y^r nearest Coniunction & Uniformity in matter of
Religion, that full unity & uniformity in Religion according to
y^r Covenant, as after consultations advice givⁿ from y^r divines
of both Kingdoms now assembled shall be jointly agreed upon.

by both Houses of the Parliament of England & by the Council & Kingdom of Scotland, be confirmed by Act of Parliament of both Kingdoms.

6 That for the more effectually disabling of schism, heretics, papists & popish recusants from disturbing the State & obiding the Lawes, & for the better discovering & speedy conviction of recusants An oath Established by Act of Parliament to be administered to them, wherein they shall abjure & renounce the Popes supremacy, the doctrine of transubstantiation, purgatory, worshipping of the consecrated Host, Crucifixes, Images, and refusing the sayd oath being tendered in such manner as shall be appointed by the said Act: to be a sufficient conviction in Law of recusancy.

7 An Act of Parliament for Education of the Children of papists by Protestants in the Protestant Religion.

8 An Act for the more speedy removing of the Penalties against them who are Penalties to be levied & disposed in such manner as both Houses shall agree on, wherein to be provided that the Manors shall give noe Coffee.

9 That an Act be prepared wherein the practices of papists against the State may be prohibited and the Lawes against them duly executed & a stricter course taken to prohibit the saying or saying of Masse in the Court or any other parts of his Kingdome.

10 That the Bill for the Kingdom of Scotland concerning the 4 last Propositions in such manner as the Estate of Parliament there shall think fit.

11 That the King doe give his assent to the Act and Ordinance & give assurance of his consenting in the next Parliament of Scotland, to an Act, ratifying the Acts of the Convention of Estates of Scotland called by the Council & Conservators

13 That as act of Parliament be passed to make void y^e Oath of Fealty in Ireland & all treaties wth y^e Rebels wth out consent of both Houses of Parliament and to settle y^e prosecution of y^e warre in Ireland in both Houses of Parliament to be managed by y^e Joint advice of both Kingdoms according to y^e ordinaunce of y^e 11th of April last & y^e King to assist & to doe noe act to discontent or molest t^{he} t^{he}re.

14 That as act be passed in y^e Parliament of both Kingdoms respectively for Establishing y^e Joint declaration of both Kingdoms wth y^e qualifications ensuing.

1 That y^e y^e y^e shall expect noe pardon be andly t^{he} following t^{he} names of y^e y^e to be excepted.

2 All papists & popish recusants wth have bene now and or shall be actually in arms against y^e Parliament or voluntarily assisting t^{he}re to.

3 All persons wth have had any hand in y^e plotting & designing y^e rebellion in Ireland.

4 All Irish rebels wth ever papists or other wth have and or shall come over from Ireland & have assisted or shall assist in t^{he} warre against bot Houses of Parliament.

5 That

may be removed from his Majesty's Council & may be
restrained from coming wh^{er} in his Majesty's Court & wh^{er}
they may not beard any office or have any employment,
concerning his Majesty's State or Common Wealth & in case any of them
shall offend therein to be guilty of high treason & incapable
of any pardon of his Majesty's grace & these Estates to be disposed of
as both houses of Parliament in England or his Majesty's Estates of
Parliament in Scotland respectively shall think fit.

6 And wh^{er}soever wh^{er}soever shall be taken wh^{er}soever not only
save defected his Majesty's Parliament but save noted both King
doms traitors

7 The person of all others to be free not wh^{er}soever standing any
act or thing done in or concerning this above they
taking his Majesty's consent

8 The Estates of prelates to be disposed according to his
Majesty's articles of his late treaty of both Kingdoms.

9 A tenth part upon full value of his Majesty's Estates of his
Majesty's person made incapable as aforesaid to be employed
for his Majesty's payment of his Majesty's subsequent debts & damage accor-
ding to his Majesty's declarations.

10 And likewise a tenth part of his Majesty's Estates of all other
delinquents wh^{er}soever in his Majesty's joint declarations & in case his
Majesty's Estates & portions aforesaid shall not
suffice for his Majesty's payment of his Majesty's subsequent engagements
beginning into this and only to be employed yet they
a new portion may be appointed his Majesty's joint advice
of both Kingdoms, providing it exceed not the
said moiety of his Majesty's Estates of his Majesty's person made incapable
as aforesaid & it exceed not a sixth part of the
Estates of his Majesty's other delinquents.

12 That his Majesty's person & Estates of all Common soldiers &

of both houses of parliament or in the intervals of parliament without the consent of the said Council & to suppress any foray or forays that shall be made into this kingdom & that it shall be high treason in any who shall devise any foray without the full consent of the said Council under the great seal or other warrant to the contrary notwithstanding and they to be incapable of any pardon from the nature of their estates to be disposed of at both houses of parliament shall hereafter.

2 To preserve the peace now to be settled & to prevent all disturbances that may arise by reason of the late troubles & to be provided by force & to guard & determine all violators of the articles among the subjects of the Kingdom of England.

So for the Kingdom of Scotland

3 To have power to send part of them selves for as they exceed not a term part or be not under the number of to reside in the Kingdom of Scotland to assist & vote at such & such as the Council of Scotland in these matters wherein the Kingdom of Scotland is only concerned.

So for the Kingdom of Scotland.

4 That the Council of both Kingdoms may meet at a joint Council at such time shall be caused or send part of themselves at a time so to do as follows.

1 To preserve the peace betwixt the Kingdoms & the King & every one of them.

2 To prevent the violators of the Articles of the peace at a time so or any troubles arising

in y^e Kingdomes & to heare & determine all differ-
ences & controversies if may accorde wth y^e same according to y^e treaty
& to doe further according as t^{he}y shall respectively
receave instructions from both houses of Parliamt^t
in England or y^e Estates of Parliamt^t in Scotland &
in generalle of Parliamt^t from y^e Commissioners.

3 To rayse & finde y^e forces of both Kingdomes to
resist all forraigne invasion & to suppress any forces
raised wth in any of y^e Kingdomes by authority under
y^e great seale or other warrant wth save wth
out consent of both houses of Parliamt^t in England
& y^e Estates of y^e Parliamt^t in Scotland or y^e Com-
missioners of y^e Kingdomes w^{ch} of t^{he}y are subiects
& y^e is t^{he}se castles of joint concernment to both
Kingdomes y^e Comd^r to be directed to be t^{he}re
all or full part as a force to act & to direct at
joint Commissioners of both Kingdomes.

4 To order y^e warr of Ireland according to t^{he}
ordnance of y^e 11th of Aprile & to order t^{he} militia
& conserve y^e peace of y^e Kingdom of Ireland.

18 That y^e matters quere y^e Assent to wth save wth y^e two Kingdo-
mes shall agree upon in execution of y^e Articles of y^e
Londⁿ treaty w^{ch} are not yett finished.

19 That an act be passed y^t all orders made f^{or} y^e
day of t^{he} & w^{ch} shall hereafter made shall not
sit or vote in y^e Parliamt^t of England wth out consent of
both houses of Parliamt^t for for y^e Kingdom of Scotland

20 That an act be passed y^t y^e Lord Keeper, Lord Treasurers, Depu-
ty of Ireland Judges of both Benchs & of y^e Exchequer &
shall be nominated by both houses of Parliamt^t to continua

in the same manner & in intervals of Parliament by the
aforesaid Com^{rs} to be approved or disallowed by both Houses at their
next sitting.

To be law for the Kingdom of Scotland in full manner
as the Estates of Parliament there shall think fit.

21. To send a proposition for education & marriage of the King
of Scotland.

22. To send a proposition for uniting the Protestant Churches against
the Papists & concerning the restitution of the Province
of Scotland.

23. To send a proposition concerning former negotiations & concluding
peace & union with former provinces and States.

24. To report the desire of the Committee that some Members of both
Houses may be sent to the Lord Mayor & City of London & Common
Council to acquaint them with the said matters and passing propositions
for a safe & well grounded peace & that both will be ready to
take in to consideration such propositions as they shall
presently see the advantage of the City of London.

To be law for the City of Edinburgh to be sent to the
Parliament of Scotland or their Committee

25. As a way of observing the Exceptions relative to the qualifications
in the Proposition aforesaid for the joint Declaration & the other
Exceptions of the Houses shall think fit.

To be law for the Kingdom of Scotland.

26. A proposition for disbanding the Armies

That consideration be had of the said matters & conclusions & that
shall be uniform in terms to the King from both Kingdoms
