wij gaan akkoord met inlichting allen dulles
als in uw driehonderd vijftiendertig bedoeld stp hoewel
ten overvloede wijzen wij er nogmaals op dat het volstrekt
niet onze bedoeling is indonesiers zwart maken doch
slechts on record gaan voor geval nieuwe processen
worden geentameerd op basis van door weinreb gezien
dossier stp wij v r a g e n amerikanen derhalve
niets doch indien zij ondanks uw mededeling dat documen
ten strikt vertrouwelijk zijn niettemin bijvoorbeeld
cumming zouden vragen of hem iets over deze frame
up bekend is en indien op die wijze indonesiers er
achter zouden komen dat iets over hun voornemens is
uitgelekt zou zulks o i geen kwaad kunnen aangezien
wellicht mogelijkheid bestaat dat indonesiers alsdan
van eventuele uitvoering plan zouden afzien stp wij
zullen voorshands van inlichting matthews afzien doch
u zou allen dulles kunnen verzoeken u aanstonds te
waarschuwen zodra hij state department inlicht aangezien
het ons alsdan noodzakelijk voorkomt matthews eveneens
vertrouwelijk in te lichten stp op deze wijze kan
tevens bereikt dat weinreb wordt uitgenodigd persoonlijk

stp gehele gezin weinreb inmiddels gerepatrieerd stp
verband vacatiebezetting vertaalbureau en achter

which he requested me to peruse stp the president himself acted as a guide and interpreter because the documents had been drawn up in indonesian a language which i am not yet able to understand easily stp this dossier comprising some threehundred fifty pages is perplexing uitrptkn i know much about dossiers indeed stp for three years i myself was obliged to remain a passive looker on while a number of scoundrels and idiots made up a dossier against me without my being able to defend myself stp at the time the only thing i could do was to refute that dossier cma pointing out all inconsistencies cma impossibilities cma etc stp so i know how to read dossiers stp if you life is at stake you learn these things better than anywhere else stp well cma that first time i studied the dossier for about two hours assisted by the president who answered all my questions willingly and with ekspert knowledge stp i must say that this dossier presents a tremendously strong case stp all the mistakes that have been made in the cases that are being tried at the moment have been avoided stp there are hardly any mistakes to be detected stp on the other hand it is not too perfect unquo either stp in some respects there remain gaps that only serve to strengthen the impression of authenticity stp wherever necessary depositions made by witnesses are supported by hk intercepted cma stolen or copied slthk letters cma by other depositions cma newspaper reports cma fragments from speeches cma advertisements hk the teksts of which are unintelligible to outsiders slthk cma statements of banking accounts cma contracts cma movement orders cma tickets hk including cancelled tickets slthk cma luggage from which the customs officers had taken documents which they had copied and put back in the luggage without this being noticed cma purchase and sale notes of all kinds of commodities cma photographs hk including photographs of certain meetings or of persons before or near a certain house or building slthk cma etc etc stp the dossier is directed against quo the leaders of netherlands imperialism unquo and it implicates dozens of dutchmen who apparently take a prominent place in this respect stp it further implicates a number of other foreigners hk an englishman cma a belgian cma a portuguese cma a pole pntcma there were some more but i do not remember them slthk and a few score of indonesians stp the dutchmen are not really mentioned by their names but rather are indicated by their functions cma e g n n managing director of pntje pntje pntje pntcma a b c cma director of

pntje pntje pntje stp i believe that the notorious team of the big five is mentioned in full together with their followers and various well known indonesians stp since nineteenhundred fifty hk in some cases since an earlier date slthk these persons have systematically committed all sorts of acts which were aimed at weakening the position of the republic of indonesia or at destroying it altogether stp these acts were committed by these persons not only in a private capacity but also and principally by virtue of their office hk that is why the number of these cases decreases when certain persons have left and have been succeeded by others slthk stp the acts referred to above comprise dbbpnt eksposing the republic of indonesia to the ridicule of the world with a view to injuring its prestige in order to prevent foreign investments and to cause the liquidation of eksisting investments hk evidence dbbpnt newspaper articles cma speeches cma letters cma conversations cma depositions of witnesses slthk pntcma ridiculing the republic of indonesia in order to weaken the position of the rupiah cma to cause an outflow of gold and to weaken the republic's foreign ekschange position cma to disorganise banking and the import and eksport trade hk evidence dbbpnt the same as mentioned above and also the bribing of prominent indonesians dash statements made cma inter alia in switzerland cma by bank employees some of whom no longer work in indonesia and also by bank employees who still work there undash depositions made by witnesses and correspondence about these matters dash sometimes in camouflaged language cma sometimes in a code which was decoded cma however undash telegrams cma telephone calls cma overheard conversations slthk cma to paralyse the indonesians themselves by means of inferiority komplekses hk the same evidence as mentioned above slthk cma to disorganise everyday life in this country hk the same evidence as mentioned above cma and also the giving of contrary directions cma bribing again cma commercial transactions mainly aimed at this object hk and cma note cma complete with invoice and all other documents slthk pntcma supporting unnational parties hk inter alia supporting the p k i dash i e the communist party in indonesia undash in order to sow unrest and to incite foreign countries against indonesia pntcma evidence dbbpnt a special code with the p k i cma correspondence with the communist party dash with quo genuine unquo note paper heading and with signatures which were verified by handwriting eksports who found them correct -4-

cma e g hazainie cma wongso and others cma with
a view to promoting squabbling slthk pntcma supporting
gangs hk many kinds of evidence dbbpnt letters cma
receipts cma documents contained in the records dash
mostly drawn up in camouflaged language such as dbbpnt
it is high time for john to be operated on cma or

after having first been photographed cma with detailed

note of dismissal pntcma further the supply of bases
around java for the purpose of attacking java itself
hk the evidence includes shipping documents covering
shipments of all sorts of commodities by the kjcpl
hk royal java china packet line slthk cma smn hk netherlands
steamship company slthk cma kpm hk royal packet company
slthk cma hal hk holland america line slthk cma
correspondence about these shipments cma
depositions made by witnesses cma etc slthk pntcma
policy aimed at undermining the state cma giving wrong
advice cma starting an agitation in the national and
international press cma for the purpose of creating
unrest and revolution in order to justify american
intervention in order to restore order and peace at
the request of the quo honest unquo government hk seyss
inquart in vienna is mentioned as an eksample slthk
cma an arrangement having been made with the americans
to set up a pro netherlands government which will enter
into a quo close union unquo and participate in seato
stp for that purpose bases in netherlands new guinea
are being supplied hk evidenced by numerous documents
dbbpnt photostat copies of quo authentic unquo documents
cma conversations with ambassadors overheard by servants
who have been especially trained for the purpose pntcma
these servants profess to be illiterates but they hear
and understand everything slthk stp
many hundreds of people are said to have been
killed as a result of the acts committed by these
people stp in many cases such persons were polished
off hk according to witnesses an amount of five hundred
rupiahs was generally paid for murdering a certain
person and for disposing of the corpse slthk which

means murder stp also sabotage cma treason cma high treason cma bribery cma currency smuggling cma assisting the enemy cma violation of the secrecy of the post office cma larceny cma etc stp

i have merely given a number of eksamples stp the dossier is a very good one stp if i had not known better i should have been prepared to believe at least part of it ultriptkn there are for instance letters from the high commissariat hk with letterhead and signatures slthk addressed to the commissioners in indonesia containing orders as mentioned above cma including orders to help certain persons to get out of the country both in a favourable and an unfavourable sense pntcma to sow dissension cma to ekscite envy stp these letters cma too cma were sometimes written in code on ordinary white paper but in such cases it appears that the letter has been written on a typewriter belonging to the high commissariat which is proved by comparing it with other hk harmless but official slthk letters in which the same typewriter letter shows eksactly the same defect stp certain things are proved by finger prints cma objects cma books cma painting stp

after that first time i studied the dossier another four times cma mostly by myself in a separate room stp sometimes the president came in for a few moments stp once pringgodigdo also came to have a look stp another time a man i did not know came in to peruse the dossier with me pntcma he knew quite a lot about the affair and cma in my opinion cma he must have been one of the men who made the dossier stp he was not introduced to me cma his english was very bad cma he did not speak dutch but he did speak indonesian although with a foreign accent stp he looked european with a touch of chinese stp he was very cordial towards me but at the same time very careful stp

last week there was a discussion on the dossier stp besides the president and pringgo there were mr. aidit cma dr thung cma dr iwa cma dr suprapto hk djody s solicitor slthk cma dr budhyasto hk member of parliament of the progressive party slthk dr yamin cma dr ali sastro cma three european looking gentlemen who spoke english and indonesian hk the unknown gentleman i mentioned in the previous paragraph was one of them slthk cma a number of high ranking military and police officials whom i did not know cma however stp it was tacitly assumed that the contents of the dossier were in conformity with the facts and the discussed the procedure to be adopted in the quo machtuebernahme unquo hk this word was used by dr ali slthk stp they

spoke slightly of the government i e the then
masjumi cabinet of mr harahap which they considered
to be a house of cards stp unquo
vertaling passage blz elf quo
curiously enough those dossiers were not simply
shown me cma they were practically thrust under my
nose stp i had to see them and hear everything about
them stp the necessity of preserving secrecy was never
even alluded to stp i was under the impression that
i was being forced to hear their lectures stp they
know that i associate with several dutchmen stp were
they ekspecting me to tell about the affair vrgtkn
did they want to intimidate me vrgtkn just as the
germans and the russians do by means of their secret
police vrgtkn in fact cma the fear of an event which
is viewed as inevitable is worse than the event itself
stp fear has been the means to soften people and make
them pessimistic stp is it their intention to have
it leak through in this way vrgtkn it is just a supposition
of mine stp of course i do not know for certain stp
unquo.
