notes were received on march second and april
twentieth and an aide memoire on may first nineteen
hundredfiftysiks cma from the embassy of the nether
lands concerning certain important outstanding problems
in the relations between the netherlands and indonesia
stp these notes and the netherlands ambassador's
oral comments and requests in connection with these
problems have been given careful attention and consi
eration stp

with respect to his note of april twentieth
cma the ambassador inquired whether the netherlands
government could expect the support of the united
states government if the netherlands government should
decide cma in case the indonesian government remained
in default with respect to its obligations under the
netherlands indonesian loan of nineteenhundredthirty
seven a cma to appeal to the united nations commission
for indonesia stp the united states government has
decided that it is not in a position to make a deter
mination at this time with regard to this subject
cma particularly as it appears that the final decision
of the indonesian government has not been reached
stp

in a conversation with the deputy under secretary
of state on april thirtiest cma and in the aide memoire
presented by an officer of the embassy on may first
cma the ambassador requested the intervention of the
united states on behalf of certain dutch prisoners
held by the indonesian government stp in a conversation
with the secretary of state on may eleventh the
ambassador stated that the netherlands government
hoped the secretary might find it possible to talk

to the indonesians cma during president sukarno's visit cma about the importance and desirability of improving relations with the netherlands which is cma in turn cma anxious to reciprocate stp in this connection cma the ambassador mentioned several moves by the indonesian government which were not conducive to the improvement of relations such as the suspension by indonesia of payments on various financial obligations assumed by them at the round table conference stp

as the netherlands embassy has been informed cma the united states government has made such statements regarding both of these matters cma when suitable opportunities have been presented themselves cma as it believes are appropriate and helpful stp
