infiltrators cma armed with rifles and pistols cma
in the same territory from a boat could be frustrated
as the vessel was intercepted pntcma the men in it

orders to infiltrate near fak fak cma were taken into
custody stp

these actions form part of an act of aggression
cma clearly prepared and intended as such by the responsible
government dash and army authorities in djakarta stp

Cma our armed forces will enter the country unquo pntkma
c minister subandrio cma who cma according to an
a f p report of may siksteen cma oneninesikstwo
Cma stated that quo the indonesians will go to war
if the dutch prefer to settle the dispute about west
irian in that manner unquo stp

with serious concern and with indignation the
netherlands government has taken cognizance of these
new unjustifiable aggressive acts and indonesian threats
for the imminent future against the non self governing
territory of west new guinea cma which the netherlands
temporarily administers on the basis of article
seventy three of the charter of the united nations
stp the government deplores these acts all the more
because dash in spite of previous similar aggressive
acts and statements directed against the inhabitants
of west new guinea undash it not only cma immediately
on january eighteen cma declared itself prepared
dash in reply to your renewed initiative and personal
urgent request of january seventeen undash to seek
a peaceful and just solution of the eksisting dispute
with indonesia concerning the further development and
future status of the inhabitants of this territory
cma but has also continuously and strictly refrained
from any hostile behaviour with regard to indonesia
cma either in word or deed stp

the netherlands government's peaceful and constructive
approach to the new guinea question was recently again
clearly demonstrated by the positive netherlands reaction
to the proposals of mr bunker cma the mediator acting
under your auspices cma when dash although indonesia
had interrupted the talks undash the government declared
all the aspects of the said proposals together with
all items related to this problem deemed relevant
by either party stp

although cma at present cma the netherlands
government is not yet aware whether the indonesian
government has also given you a positive reaction
to these proposals cma it nevertheless asks itself
in honest concern whether this ekschange of views
on a peaceful solution to the dispute can now be
continued as if nothing had happened cma while indonesia
perseveres in regularly committing aggressive acts
against the territory in question hk which cma moreover
cma she openly designates as such slhk cma thereby

flagrantly violating the first principles of its membership of the organization of the united nations stp this cannot be considered to be in the interest of peace in that part of the world cma the maintenance of which is cma after all cma the primary task of the united nations stp it also raises the question whether dash and in how far undash the indonesian behaviour diminishes the possibility of eventually having confidence in the achievement of a really bona fide settlement for the further development of the papuans toward self rule and free choice of their own future. cma in conformity with the aim ekspressed in article seventy three of the charter cma if the united nations organization were not to take a clear stand in favour of the maintenance and observance of its own principles stp

the netherlands government sincerely regrets that thus dash in spite of its continuing willingness to consult undash and cma if so desired cms to co operate dash with the united nations with regard to the future development of the papuan people of west new guinea and the future status of that territory undash the peace in that part of the world is continually being jeopardized by indonesia cma in word and deed stp in this conneksion the government wishes to recall its offer cma made on april twenty seven cma of the maintenance of a military status quo under impartial control pntcma an offer which is hereby emphatically reiterated stp

meanwhile the netherlands government considers the situation created by the aforementioned new aggressive behaviour of indonesia to be such that it deems it necessary to weigh further what action it may take cma within the framework of the united nations stp.

in the light cma however cma of the good offices you have rendered for the attainment of a just and peaceful solution of the present problem dash which good offices we have greatly appreciated and to the continuation of which we attach eminent value undash the netherlands government feels encouraged and entitled cma before taking any action cma to make an urgent appeal to you to remind indonesia of her primary obligations under the terms of the charter of the united nations cma and to ekshort her to refrain from all aggressive action cma whether in word or deed cma against the territory and the people of west new guinea

cma in order that the continuation of a justified discussion of the future of this non self governing territory be not placed in jeopardy stp.

furthermore dash in the same context and especially in the interest of the further maintenance of peace in that part of the world undash the netherlands government desires urgently to reiterate its former request to you to send some observers to the region in order that they may take note of the factual situation and contribute cma by their presence cma to the prevention cma if possible cma of further aggression stp.

finally the netherlands government wishes to give to you once more cma as a closing sentence of this letter cma the assurance that dash in the light of the fact that its presence in netherlands new guinea is cma on principle cma of a temporary character undash it will continue to lend its fullest and most positive co operation to your personal efforts cma as well as to those of members of the united nations engaged in similar attempts cma to find for the inhabitants of this non self governing territory an honest and just solution on the basis of article seventy three of the charter of the united nations and the terms of the resolutions on decolonization of december fifteen cma oneninesikszero and november twenty eight cma oneninesiksone stp.
