may i give you a brief review of the latest developments
in indonesia vrgtkn i shall try at the same time to
answer as best i can sir f roberts question of last
week stp

these are the developments i have to mention
to day dbbpnt

p r i m o the indonesian government is attempting
cma not without success cma to carry through a sort
of news black out stp facilities for press agencies
to send sikshundred words per day at a reduced rate
have been cancelled cma result being that telegraph
costs have become prohibitive stp foreign newspapers
are considering the withdrawal of their correspondents
stp only russian and chinese press agencies continue
to send long telegrams stp the impression prevails
in djakarta that indonesian news sources are observing
a voluntary censorship cma from fear that they may
be accused of assisting dissident elements stp
s e c u n d o this state of affairs has contributed
to creating an unclear situation stp the focal point
of ferment is sumatra cma which island is almost as
large as france stp such reports as we have concerning
the situation in sumatra hk you know that our consulates
have been closed slthk do not leave the impression
that early establishment of a counter government
seems very likely stp there certainly appears to be
no plan for a secession of sumatra stp it may be cma
though cma that a kind of shadow government could
come into being there which cma however cma for the
moment could do little more than bide its time stp

the dissident elements in sumatra and elsewhere
are hampered primo by a lack of cohesion between the
many scattered islands and areas therein outside java

cma and resulting lack of coordination of activities
cma secundo by differences of views between military
commanders cma particularly in sumatra cma where one
cma in the center cma appears to favor a complete
break with the government in djakarta cma whilst
another in the south hesitates cma keeping all avenues
open stp this man is important cma because he controls
the oil on which java depends stp the commander of
northern sumatra is loyal to the government stp

former vice president hatta so far continues
to keep away from the dissident elements stp

there is also considerable uncertainty as to
whether they will be supported by army units in java
stp the small navy takes no part in these political
manoeuvres cma and the air force is in favor of sukarno
stp militarily cma the dissidents are unable to take
action against java stp

although it may well be true that some influential
political figures and also some disaffected colonels
seem to have passed the point of no return cma their
statements should be taken with some reserve cma
smacking as they do of propaganda stp the same applies
cma for that matter cma to government statements stp
considering that the dissidents have not so far demanded
sukarno's elimination cma and knowing the indonesians
with their preference for the line of least resistance
cma some form of a deal is not to be ruled cma although ~~out~~
as things go in indonesia it is not likely that such
a deal could justly be called a real solution stp
tertio as you know cma the indonesian president
has considerable leftist leanings cma and the central
government and several areas in indonesia cma particularly
java cma are strongly infiltrated by communists stp
for that reason cma as jonkheer de ranitz said last
week cma we continue to believe that cma from the
point of view of interests of the western world cma
it is highly desirable that no arms of any consequence
should be delivered to indonesia by nato countries
cma for they may well get into hands hostile to the
west cma and they may be used against the outer islands
where the communist danger is less immediate than
in java stp we are glad to think that this point of
view is increasingly understood by our partners cma
and we trust this will from now on be common practice
stp

quarto in the fourth place cma i have been
asked to inform the council that we have presented
to our nato partners and to a number of other govern
ments a translation of a note addressed by our charge

d affaires in djakarta to the indonesian government on december thirty stp in it cma we raised a strong protest against the measures carried out or contemplated by or on behalf of that government against netherlands business enterprises cma which had been or were to be taken over or deprived of their liberty to conduct their own affairs cma and subjected to various forms of supervision cma hindrance cma discrimination cma and spoliation stp there is no doubt that the position of the west was seriously impaired when it became clear that the indonesian government could do this with impunity stp that government has not replied to our note cma and has continued to apply the measures against which our protest was directed stp

i think that everyone will agree that the rights and title of my compatriots to the properties in question cannot be impaired by unlawful and arbitrary acts on the part of the indonesian government pntcma the same applies with regard to the produce of such properties cma agricultural cma industrial or otherwise stp the owners are of course entitled to enforce cma outside of indonesia cma by any legal means open to them their rights to any such property wherever it may be in case of unlawful eksport stp we want to be as fully cooperative with our friends as we can cma and therefore have ekspressed the hope cma and offered the suggestion cma that interested parties in other countries take up contact with netherlands owners of properties taken over as to ownership or the free ekserecise thereof by the indonesian government cma before concluding with that government cma its agents or nominees deals with regard to those properties or their produce unquote
