soon after appearance of certain erroneous press reports on subject of approval of licences for eksport to indonesia of certain equipment cma my government authorised me if queried to correct those reports stp in order to set record straight i should like to make following comments which are in line with my statement to nac on february twelve that us would keep nac informed developments this subject stp these press reports unfortunately distorted true facts in this matter which are as follows dbbpnt

us has approved licenses for eksport to indonesia of items amounting to approksimately eenenmatwee million dollar stp approksimately negen en negentig percent of these items are spare parts for indonesian civil airlines garuda cma indonesia air force and police stp only arms included in these licenses are tweehonderd vijftig colt revolvers for navy cma four sporting rifles and three pistols of twee en twintig caliber cma amounting in value to veertiencolvijfhonderd twee en tachtig dlr stp these licenses which have been pending for sometime involved private commercial transactions with american business firms stp grant aid is not involved and in no case is us government the supplier stp

subsequent to these licenses cma approval has been granted for a license covering the annual purchase of zeshonderduizend dlr worth ammunition for indonesian police stp

my government has authorized me to make clear that licensing of these items involves no change in us policy concerning delivery of arms to indonesian government which i outlined to nac on february twaalf unquote
