volgt tekst nota:

'as it is the country nearest the area of possible conflict over west new guinea, the philippines is interested in promoting a peaceful solution of the dutch-indonesian dispute. the philippine government has an obligation under the united nations charter to help prevent a breach of the peace that could trigger off an armed conflict, the extent of which cannot now be foreseen. the philippines cannot, therefore, remain indifferent to this grave risk.

over the past several days, the secretary of foreign affairs has been holding separate informal conversations with his excellency, and with the ambassador of indonesia. in the absence of diplomatic relations between their two respective governments, these conversations have served to establish a necessary link between them. in these conversations all possible avenues of peaceful agreement were explored, and on the basis of these exchanges of views the philippine government is convinced that such a peaceful solution is feasible and that armed conflict can be avoided. this conclusion is drawn from the fact that both governments have abandoned the inflexible positions they have long previously held.

the philippine government feels that the time has come when both governments should consider the desirability of sitting at a negotiating-table in order to thresh out, in candour and goodwill, the elements of a just and peaceful solution.

it therefore urges the two governments to give their full cooperation to his excellency u thant, the secretary-general of the united nations, in his sincere efforts to establish a basis for peaceful negotiations between them.

should both governments agree at some stage of these conversations that the good offices of the philippine government would yield fruitful results, the philippine government would hold itself available for that purpose.
