hoofd zuid oost azie afdeling foreign office verschafte mij onderstaande tekst van gisteren verzonden instructie aan britse zaakgelastigde djakarta naar aanleiding van persberichten dat indonesisch parlement eenstemmig president sukarno zou hebben verzocht nederlands aandeel in unilever en shell over te nemen quoote

reuters today carries report that indonesian parliament have unanimously requested the president to take over dutch interests in mixed foreign companies and to break off economic relations with the japanese should the karel doorman go to that country stp if this report is true you should ask to see the foreign minister immediately and press him for information as to what is contemplated stp

the netherlands government cma who have been consulted this afternoon by her majesty's charge d'affaires in the hague cma have asked that we should not make any representations which link the contemplated action against mixed companies with the movements of karel doorman stp you should therefore enquire of the indonesians what are the reasons for this sudden request for action against mixed companies stp if they should themselves say that it is because of dutch actions over the karel doorman cma you should reply that we cannot accept that our interests should suffer because of an unconnected matter of this kind stp nevertheless you should point out to them that they are acting under a misconception in that we have now been informed by the dutch government that the karel doorman will be leaving new guinea and will not be returning there as has been rumoured in djakarta cma which they will already have heard from the japanese stp bracket for your own information we understand from the dutch that they have authorised the japanese to speak to the indonesian ambassador in tokyo in this sense unbracket
