on march seventeen the counsellor saw mr suwanto cma deputy head of european division in the department of foreign affairs cma and told him her majesty's government were anxious to receive a reply to the communication which i had handed to the secretary general on march ten stp

suwanto replied that the indonesian government could not withdraw their demand cma and would not allow another government to assume the protection of dutch interests stp the development of relations between the netherlands and indonesia had been such that the indonesian government did not consider it worth while to have any government protecting dutch interests in indonesia or indonesian interests in the netherlands stp the indonesian government felt cma moreover cma that if another government were to assume protection of dutch interests cma indonesian relations with that government also would be jeopardized stp

the counsellor then asked the result of the indonesian government's deliberations bracket group undecipherable unbracket possible solutions to many practical problems to which their action had given rise bracket paragraph eight my telegram onehundred thirtyfive unbracket stp

indonesian government generally were fully aware of the humanitarian problems involved and were determined that full regard should be paid to them stp they had decided that the indonesian red cross should be responsible for meeting the humanitarian needs of dutch nationals in indonesia and the indonesian red cross had accepted the task stp the government would prefer that the indonesian red cross should deal with the international red cross cma but the indonesian red cross had suggested the operations might be conducted more efficiently and speedily if they dealt direct with the dutch red cross stp the indonesian government were considering this suggestion and had not yet decided whether they would permit direct relations between the two national red cross organisations stp

suwanto went on to say that the indonesian red cross were now ready to begin their work of assisting dutch nationals cma but that the organisation's attitude at present must cma of necessity cma be passive stp everything depended upon the willingness or otherwise of the dutch government to allow their nationals to receive help from the indonesian red cross and to furnish the latter with all the necessary data stp he added that the indonesian government had no objections to the departure from indonesia of quo regretful optants unquo who wished to leave for the netherlands or elsewhere cma and would allow ships to come to indonesia for the purpose of repatriation provided they did not fly the dutch flag stp

the counsellor said that the views of the indonesian government would be reported to london stp he emphasized the magnitude of the practical problems involved and gave a description in general terms of the work which had been carried out by the netherlands interests section stp suwanto seemed already well aware of the size of the problem cma but professed to believe that the indonesian red cross would be able to cope with it stp

the counsellor's impression is that the indonesian government have decided against allowing even the international red cross to undertake this work in indonesia stp this cma however cma need not deter us from arguing the merits of the international red cross if the netherlands government wish stp
