in djakarta delivered a note to the indonesian department
of foreign affairs on the twentieth of august cma
informing the indonesian government that cma subject
to their agreement cma her majesty's embassy in djakarta
would cma from the date of the departure from indonesia
of the netherlands charge d affaires cma deal with
all business concerning the custody of the property
of the netherlands government in indonesia cma including
the buildings cma archives and other property of the
netherlands diplomatic mission in djakarta cma and
with all matters relating to the protection of netherlands
citizens and of netherlands interests generally in
indonesia stp on receipt of this note cma the indonesian
department of foreign affairs informed her majesty's
charge d affaires that the indonesian government had
no objection to the assumption by her majesty's government
