dr subandrio yesterday evening cma december nineteenth
 cma delivered a government statement on this matter
 to the house of representatives who later unanimously
 endorsed the president's command en ekspressed readiness
 to eksecute it with all its consequences stp
 two the foreign minister used some strong language
 but indicated that the door to a peaceful settlement
 was still not closed stp

subquo we cannot wait any longer stp it is imperative
 for us to settle this problem as quickly as possible
 cma both in view of the safety of the state and
 nation and to preclude international tensions which
 may develop subunquo developments in goa cma he added
 cma were a proof that colonialism must be countered
 by force stp subquo faced with a continuation of dutch
 attempts to separate west irian for ever from the
 sovereign territory of indonesia cma there is no other
 way for us but to throw the dutch military occupation
 forces out of it stp subunquo indonesia could not be
 blamed for such action if she were confronted with
 a dutch f a i t a c c o m p l i in the form of a
 proclamation of what the dutch called quo independence
 for a papuan state unquo stp the dutch should not
 under estimate indonesia's strenght stp they should
 not consider the hand ekstended by president sukarno
 as a sign of weakness but as a final appeal to seek
 a peaceful way stp dr subandrio emphasized cma however
 cma that while bilateral negotiations might yet be
 possible cma no initiative to this end would be taken
 by indonesia stp
 three dr subandrio mentioned also that pressure had
 been eksercised by foreign countries on indonesia
