indienen stp quote

in the last few months official indonesian  
quarters have repeatedly and openly accused the netherlands  
government of aggressive acts and intentions against  
the republic of indonesia stp one of the most striking  
examples of these accusations is the letter of the  
indonesian permanent representative to the united  
nations of december twenty three cma nineteenhundred  
and sikssty cma addressed to the secretary general pntkma  
in this letter the netherlands is accused cma amongst  
others cma of quo a preparation for an all out aggression  
against indonesia unquo stp

the netherlands government has already rejected  
these accusations in its letter to the secretary general  
of january four cma nineteenhundred and siksstyone stp

the netherlands government is cma however cma  
of the opinion that cma in spite of the severance  
of the diplomatic relations between the kingdom of  
the netherlands and the republic of indonesia cma there  
are reasons for addressing itself also directly to the  
indonesian government through h b m s government  
of the united kingdom of great britain and northern  
ireland cma which is looking after its interests in  
indonesia stp

the netherlands government regrets that the  
indonesian government continues to cast aspersions  
on the netherlands government's intentions in spite  
of the statement made by the netherlands minister of  
foreign affairs on october sikssty cma nineteenhundred  
and sikssty in the general assembly of the united nations  
cma on which occasion he said dbbpnt quo that my country  
could possibly harbour any idea of aggressive intentions  
towards indonesia is a notion so fantastic that i cannot

conceive that any sensible person would give it credence  
unquo stp

the netherlands government has taken this step  
to give the indonesian government the official and  
unqualified assurance that it has no aggressive intentions  
whatsoever towards the republic of indonesia stp  
since nineteenhundred and fourtynine the netherlands  
government has always fully respected indonesian  
sovereignty and has not the slightest intention to  
violate it stp

it would be impossible to find a single fact  
belying this netherlands policy stp in particular  
the allegation that the presence in netherlands new  
guinea of a modest military establishment should be  
at variance with the abovementioned policy is utterly  
unfounded stp

the units of the netherlands armed forces are  
stationed in netherlands new guinea solely for defensive  
purposes stp by stationing troops and naval units  
in the territory the netherlands government complies  
with its obligation under the charter of the united  
nations to protect the population in this territory  
stp it will be clear that this obligation gives the  
netherlands government the right to maintain the  
necessary defensive forces and equipment in the area  
stp

the netherlands government therefore strongly  
urges that the government of the republic of indonesia  
refrain from making accusations which it should know  
are unfounded stp

in this connection the netherlands government  
feels bound to draw attention to the following facts  
dbbpnt

a on november thirteen cma nineteenhundred and sikssty  
a group of twenty armed indonesians landed in the  
vicinity of etna bay on the south west coast in  
netherlands new guinea stp investigations have shown  
that these persons were members of the quo corps  
irian seventeen unquo of the indonesian army pntkma  
b in the night of november twentyseven dash twenty  
eight cma nineteenhundred and sikssty an indonesian  
vessel hk quo singkuan unquo slthk was intercepted  
with twelve indonesians on board cma seven of whom  
were members of the armed forces stp various items  
of military equipment were found on board cma including  
a chart of the hydrographical department of the  
indonesian navy on which the route from the aroe  
islands to the coast near etna bay had been plotted  
stp investigations have shown that this group had

the vessel carried supplies for the group mentioned

which it holds the indonesian government responsible  
and would highly appreciate to be given the assurance  
of the government of the republic of indonesia that  
similar intrusions will not occur in the future stp  
unquo
