your suggestion that i now approach the government
 of indonesia with an appeal would kma if accepted
 by me kma imply that i was taking sides in the controversy
 kma which i believe would not be in the best interest
 of all concerned stp

i feel kma however kma that a situation has arisen
 where it appears appropriate to appeal kma both to
 your government and that of the republic of indonesia
 kma to refrain from all aggressive action kma both
 in view of the obligations of the two governments
 under the charter and in order not to jeopardize the
 efforts that are now being made by ambassador bunker
 stp
